# MINUTES CITY COUNCIL REGULAR MEETING APRIL 23, 2013 - 6:00 p.m.

## CALL TO ORDER

The regular meeting of the City Council of the City of Highland was called to order at 6:00 p.m. by Mayor McCallon at the Donahue Council Chambers, 27215 Base Line, Highland, California.

The invocation was given by Tim Evans of The Unforgettables Foundation and the Pledge of Allegiance was led by Councilman Timmer.

## REPORT FROM CLOSED SESSION

No Reportable Action. Councilman Racadio abstained from Item #1 due to a conflict of interest.

## **SPECIAL PRESENTATIONS**

Mayor McCallon presented City Manager Hughes with a Proclamation proclaiming April 26, 2013 as Arbor Day in the City of Highland.

## **PUBLIC COMMENT**

Mr. Miguel Cantos stated he is present this evening to ask for support as a resident of Highland and the owner of Cantos Jewelry located in the Village Marketplace located in east Highland. In January, 2011, he was robbed at gunpoint and severely injured and also in April, 2013, he was robbed a second time. He is asking for the police to patrol the area more frequently. This is a beautiful city but the problem is safety, which is not here.

#### CITY COUNCIL PUBLIC HEARING

8. Public Hearing of the City Council to Consider the "Greenspot Village and Marketplace" Specific Plan (SPR-006-001), Final Environmental Impact Report (ENV-009-003), General Plan Amendment (GPA-009-002), Zone Change (ZC-009-001), and Design Review Applications for Planning Area 1 (PA1) and Planning Area 2 (PA2) (DRB-009-003 and DRB 009-004, respectively) and Development Agreement (DA-012-004). [Continued from April 9, 203 City Council Hearing]

Mayor McCallon stated this item is being continued from the last Council meeting and the Public Hearing is still open.

**A MOTION** was made by Councilman Timmer, seconded by Councilman Racadio, to continue this item until their May 14, 2013 Public Hearing to allow staff and the Applicant time to complete a Development Agreement related to the subject applications. Motion carried, 5-0.

#### CITY COUNCIL LEGISLATIVE

9. <u>Bid Award – Bid No. 2012-05 "Sterling Avenue Phase II Storm Drain Project"</u>

Director of Public Works/City Engineer Wong gave a brief review of the staff report.

Mayor McCallon stated it is encouraging that the City Attorney believes we can go ahead with this project.

City Attorney Steele stated this opinion is based on a letter from the Department of Finance. The Department of Finance stated if these are appropriate expenditures of bond funds then they will not question the reimbursement range. Therefore we were very diligent in tying up all the loose ends.

Councilwoman Scott stated there will not be any cost overruns on this and she loves the last paragraph and will be looking for it at the next meeting.

Public Works Director/City Engineer Wong stated what this paragraph means is this, although there is an eight month delay in awarding the contract, the low bidder is putting in writing that they will not ask for additional costs because of this eight month delay of award. It is not saying there will not be any change of the project final costs based on other reasons.

**A MOTION** was made by Councilman Racadio, seconded by Councilman Timmer, to award the contract to the lowest bidder, Laird Construction Company, Inc., in the amount of \$1,040,000 for Bid No. 2012-05 "Sterling Avenue Phase II Storm Drain Project." Motion carried, 5-0.

10. <u>Professional Services Agreement with Parsons Brinckerhoff – Greenspot Road</u> Improvements Project Construction Management Services

Public Works Director/City Engineer Wong gave a brief review of the staff report.

Councilwoman Scott stated under fiscal impact it says not to exceed the \$686,400 and with the agreement with them do you still have the same paragraph which was in Item #9.

Public Works Director/City Engineer Wong stated we did not print out the complete proposals but the not to exceed amount is in the proposal materials.

Assistant Public Works Director Zamano stated it is in the attachments on page 9, you will find the breakdown of the services being provided.

Councilwoman Scott stated this bid amount is cemented, no raises.

Public Works Director/City Engineer Wong stated unless we allow it for special reasons.

Mayor McCallon asked when will Edison be doing their undergrounding work?

Public Works Director/City Engineer Wong stated we have a meeting with Edison tomorrow and their schedule is to start construction in the latter part of this year, maybe October.

**A MOTION** was made by Councilman Timmer, seconded by Mayor Pro Tem Lilburn, to approve the Professional Services Agreement with Parsons Brinckerhoff to provide construction management services for the Greenspot Road Improvement Project. Motion carried, 5-0.
