Municipal Code Amendment (MCA-14-004): An Ordinance of the City of Highland amending Municipal Code Sections 16.56.150 and 16.56.160 to clarify the review and approval process related to new Freeway-Oriented Community Business Signs and Electronic Changeable-Copy Business Signs. Applicant: City of Highland.

Mayor Racadio opened the public hearing.

City Planner Stater gave a brief review of the staff report.

Mayor Racadio called for any speakers in favor or in opposition. Seeing none, the public hearing is now closed.

City Attorney Steele stated if Council would like to have a Motion to introduce the Ordinance minus the sections on signs, you can introduce the Ordinance that way without the sign content. We would just have to change the title. If you are so inclined to have a Motion to introduce the Ordinance, minus Section 19 of the Ordinance and Section 20 of the Ordinance which are the sections which relate to the sign, you could make that Motion and direct Staff also to correct the title of the Ordinance before it comes back to Council, which is sufficient direction for Staff to bring Council a new document for adoption at the next meeting.

A MOTION was made by Mayor Pro Tem McCallon, seconded by Councilwoman Scott, to:

1. Adopt the Notice of Exemption and instruct staff to file a Notice of Exemption with the Clerk of the Board; and

- 2. Introduce Ordinance No. 394 amending various sections of the Highland Municipal Code minus Section 19 and Section 20, and also to correct the Title to reflect the introduction as it relates to:
 - a. Cottage Food Operations;
 - b. Fixed Price Point Retail Stores; and
 - c. The synchronization of the life span of entitlements with State mandated automatic extensions of an associated tentative map. Motion carried, 5-0.

AN ORDINANCE AMENDING VARIOUS SECTIONS OF THE HIGHLAND MUNICIPAL CODE INCLUDING, TITLE 5, CHAPTER 5.12.010 CREATING DEFINITIONS FOR COTTAGE FOOD OPERATIONS, **AMENDING EXISTING** CHAPTER 5.12.020 DEVELOPMENT REGULATIONS FOR HOME OCCUPATIONS AND ESTABLISHING DEVELOPMENT REGULATIONS FOR COTTAGE FOOD OPERATIONS AND TITLE 16, CHAPTERS 16.06, CREATING DEFINITIONS FOR COTTAGE FOOD OPERATIONS, 16.44.140 AMENDING EXISTING DEVELOPMENT REGULATIONS FOR HOME OCCUPATIONS AND ESTABLISHING DEVELOPMENT REGULATIONS FOR COTTAGE FOOD OPERATIONS, CHAPTER 16.16 UPDATING THE RESIDENTIAL DISTRICTS USES TABLE AND CHAPTER 16.22 UPDATING THE MIXED USES TABLE (MUNICIPAL CODE AMENDMENT MCA 13-007); TITLE 16, CHAPTERS 16.06, CREATING DEFINITIONS FOR EXTREME VALUE RETAIL, FIXED PRICE RETAIL AND ODD-LOT/CLOSE-OUT RETAIL USES, 16.44 ESTABLISHING DEVELOPMENT REGULATIONS FOR EXTREME VALUE RETAIL, FIXED PRICE RETAIL AND ODD-LOT/CLOSE-OUT RETAIL USES, 16.20 UPDATING THE COMMERCIAL DISTRICTS USES TABLE AND CHAPTER 16.22 UPDATING THE MIXED USES TABLE (MUNICIPAL CODE AMENDMENT MCA 014-001); AND TITLE 16. SECTION 16.08.200 TO SYNCHRONIZE THE LIFE SPAN OF ENTITLEMENTS WITH STATE MANDATED AUTOMATIC EXTENSIONS OF AN ASSOCIATED TENTATIVE MAP (MUNICIPAL CODE AMENDMENT MCA 14-003)

which title was read.

12. <u>Municipal Code Amendment (MCA-11-005): An Ordinance of the City of Highland Creating Chapter 10.28 (Parking of Recreational Vehicles), Amending Chapters 16.06 (Definitions) and 16.52 (Parking Regulations) to Establish Regulations for Parking and Storage of Recreational Vehicles</u>

Mayor Racadio opened the public hearing.

Senior Planner Irwin gave a brief review of the staff report.

Mayor Racadio called for any speakers in favor or in opposition. Seeing none, the public hearing is now closed.

City Attorney Steele stated he thinks Staff's suggestion is an attempt to balance ease of enforcement, or ease of administration, with ease of compliance. The paved requirement for everything is harder to comply with, and it's going to cost people more money to comply with. Staff is trying to balance the idea of cost of compliance with cost of enforcement, and this is completely up to the Council. To amend this, we would change Page 14, Number 4. We would distinguish between motorized recreational vehicles parking which would only be on paved surface in the first sentence, and then basically duplicate this and say non-motorized recreational vehicle parking may occur on either a paved surface or pavers or gravel.

City Manager Hughes stated it would be changed to say, "Motorized recreational vehicle parking and storage shall only occur on a paved surface. Non-motorized recreational vehicle parking may occur on paved surface, gravel or pavers."

A MOTION was made by Mayor Pro Tem McCallon, seconded by Councilwoman Scott, to:

- 1. Adopt a Notice of Exemption and instruct staff to file a Notice of Exemption with the County Clerk of the Board; and
- 2. Introduce Ordinance No. 395 to create Chapter 10.28 (Parking of Recreational Vehicles), and amend Chapters 16.06 (Definitions) and 16.52 (Parking Regulations) of the Highland Municipal Code to establish regulations for parking and storage of recreational vehicles to include the amendments to non-motorized vehicles on gravel, changes to parking adjacent to and along property frontage, the hold harmless agreement requirement and the intent for street sweeping.

Motion carried, 4-1, with Councilwoman Lilburn dissenting.

City Clerk Hughes introduced Ordinance No. 395:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HIGHLAND, CALIFORNIA AMENDING HIGHLAND MUNICIPAL CODE TITLE 10 (VEHICLES AND TRAFFIC) BY ADDING CHAPTER 10.28 TO ESTABLISH REGULATIONS FOR PARKING OF RECREATIONAL VEHICLES ON CITY STREETS; AMENDING THE LAND USE AND DEVELOPMENT CODE OF THE HIGHLAND MUNICIPAL CODE, TITLE 16, CHAPTER 16.06, TO INCLUDE DEFINITIONS FOR PARKING AND STORAGE OF RECREATIONAL VEHICLES, AND ADDING SECTION 16.52.080 TO CHAPTER 16.52 TO ESTABLISH REGULATIONS FOR ON-SITE PARKING AND STORAGE OF RECREATIONAL VEHICLES (MUNICIPAL CODE AMENDMENT MCA 11-005)
