**A MOTION** was made by Councilwoman Scott, seconded by Mayor Pro Tem McCallon, to:

- Adopt a Notice of Exemption and instruct staff to file a Notice of Exemption with the Clerk of the Board of Supervisors of San Bernardino County; and
- Introduce Ordinance No. 397 to amend Chapter 16.06 (Definitions), Chapter 16.08 (Permits and Approvals) and Chapter 16.44 (Specific Development Standards) of the Highland Municipal Code to establish regulations for Food Truck Events. Motion carried, 4-0, with Councilwoman Lilburn being absent.

**A MOTION** was made by Councilman Timmer, seconded by Councilwoman Scott, to:

- 1. Approve the City's Application for Neighborhood Revitalization that supports thirty percent (30%) of the salary and benefits of the City Planner position, seventy-five (75%) of a Code Compliance Officer position and forty (40%) of an Administrative Assistant position, a total of \$123,997;
- Approve the City's Application to construct pavement rehabilitation and curb and gutter repair on local streets within the CDBG Area boundaries including Mira Vista Avenue and 13th Street in the amount of \$206,000; and
- Authorize the City Manager to sign and submit the applications to the San Bernardino County Economic Development Agency for consideration. Motion carried, 4-0, with Councilwoman Lilburn being absent.
- 12. Review and Consider a One-Year Extension of Ordinance No. 385 Municipal Code Amendment (MCA-013-005), an Ordinance of the City Council of the City of Highland Temporarily Suspending the Applicability of the City's Inclusionary Housing Requirements Described in Ordinance No. 306

Introduce Ordinance No. 398 extending for one additional year, Ordinance No. 385, an ordinance suspending the applicability of Highland Municipal Code Sections 16.50.030, 16.50.040, 16.50.050 and 16.50.080 (Inclusionary Housing Provisions). Motion carried, 4-0, with Councilwoman Lilburn being absent.

**A MOTION** was made by Councilman Timmer, seconded by Mayor Pro Tem McCallon, to approve a "no cost" MOU with San Bernardino County of Environmental Health Services and direct the Mayor to sign the MOU document. Motion carried, 4-0, with Councilwoman Lilburn being absent.

- 1. Approve a proposal from Willdan Engineering to provide construction management services for the 9th Street Safety Improvements Project; and
- 2. Authorize the City Manager to approve contract amendments up to 10% of the contract amount. Motion carried, 4-0, with Councilwoman Lilburn being absent.

Director of Public Works/City Engineer Wong gave a brief review of the staff report.

**A MOTION** was made by Councilman Timmer, seconded by Mayor Pro Tem McCallon, to:

- 1. Approve a proposal from Willdan Engineering to provide construction management services for the 9th Street and Palm Avenue Pavement Rehabilitation project; and
- 2. Authorize the City Manager to approve contract amendments up to 10% of the contract amount. Motion carried, 4-0, with Councilwoman Lilburn being absent.
