CITY COUNCIL CONSENT CALENDAR

A MOTION was made by Councilman Racadio, seconded by Councilman Timmer, to approve the consent calendar as submitted. Motion carried on a roll call vote, 3-0, with Mayor McCallon and Councilwoman Scott being absent.

8. <u>Landscape Maintenance District Contract Change Order – CAM Services (Tract</u> 15960)

Director of Public Works/City Engineer Wong gave a brief review of the staff report.

A MOTION was made by Councilman Racadio, seconded by Councilman Timmer, to approve a change order to the contract with CAM Services in the amount of \$695 per month to include regular landscape maintenance for Tract 15960 (LMD No. B-39). Motion carried, 3-0, with Mayor McCallon and Councilwoman Scott being absent.

9. <u>Amendment 2 to SANBAG Agreement Regarding SR-210/Base Line Interchange</u> Environmental Documents

Director of Public Works/City Engineer Wong gave a brief review of the staff report.

A MOTION was made by Councilman Racadio, seconded by Councilman Timmer, to approve Amendment 2 to Cooperative Agreement with SANBAG regarding preparation of environmental documents for the SR-210/Base Line Interchange Project. Motion carried, 3-0, with Mayor McCallon and Councilwoman Scott being absent.

10. <u>Contract with San Bernardino County for Animal Control Services for FY</u> 2015/2016

Director of Community Development Mainez gave a brief review of the staff report.

Mr. Brian Cronin, Chief of Animal Care and Control, spoke regarding the upcoming events for San Bernardino County Animal Control.

A MOTION was made by Councilman Timmer, seconded by Councilman Racadio, to approve the contract with San Bernardino County for Animal Care and Control Services for FY 2015-16 in the amount of \$436,202.00 and authorize the Mayor to sign the contract. Motion carried, 3-0, with Mayor McCallon and Councilwoman Scott being absent.

11. Evaluation of the Potential Reorganization of the Highland Planning Commission from a Seven Member Board to a Five Member Board [Directive from City Council on April 28, 2015]

City Manager Hughes gave a brief review of the staff report.

A MOTION was made by Councilman Timmer, seconded by Mayor Pro Tem Lilburn, to direct staff to provide a review regarding changing the current ordinance back to a five member Planning Commission. Motion carried, 2-1, with Councilman Racadio dissenting and with Mayor McCallon and Councilwoman Scott being absent.

12. <u>Update on SANBAG, SCAG, Omnitrans, Work Program and Regional/Legislative Issues/Development Issues/Subcommittees/AB 1234 Updates</u>

Councilman Racadio gave a brief update regarding the League of California Cities Board Meeting which was held on April 29-30 in Sacramento.

Councilman Timmer stated he and Director of Public Works/City Engineer Wong attended the San Bernardino Valley Water Conservation District Board meeting on May 8, 2015.
