7. Request by the Highland Area Chamber of Commerce for Action by the City Council Concerning Deficits in the Annual Citrus Harvest Festival Budget

Assistant Community Development Director Stater gave a brief review of the staff report.

Ms. Caroline Ray spoke regarding her support of this item.

Ms. Doris Diaz spoke representing Ms. Nancy Alexander, Highland Historic Society President, by reading her statement in support of this item.

A MOTION was made by Councilman Racadio, seconded by Councilwoman Scott, to take responsibility of the Citrus Harvest Festival for the 2016 year, utilize the existing funds from the Citrus Harvest Festival account to supplement staff's time and to look for partners and/or other parties who may be willing to take the Festival over in the future.

Councilman Timmer stated if you are willing to add to the Motion that we actively, over the next year, look at how we can participate with other groups or organizations. We need to get assistance with other groups to do this and again he personally does not think this is a City function to provide hot dogs and pie contests. Initially his recommendation was for this to go away but he has thought about it heavily over the last couple of days.

Councilman Racadio stated he will amend the Motion to include that we look for partners and possibly for someone to take it over in the future.

Councilwoman Scott stated not necessarily partners but take the pie contest, that's something your service clubs can take over which has been the whole burden so far of the Chamber. We need to also remember that when we had our downsides here the economy was poor. I just think we need to keep it.

Councilman Timmer stated I guess the Motion is I would support this for one year only and then we have a serious look at long term involvement of this community getting involved in this process.

Councilwoman Scott stated do you want the City to quit participating in the 4th of July parade, the Memorial Day event and so forth? I'm not sure I'm going to second the amendment.

A MOTION was made by Councilman Racadio, seconded by Councilwoman Scott, to participate in the 2016 Citrus Harvest Festival by taking it over and to fund the cost of staff's salary, in the amount of \$6,500 out of the Citrus Harvest account, and that we look for partners to help in the future in any way we can and to set the Festival date of March 26, 2016, with a rain date of April 2, 2016. Motion carried, 4-0, with Mayor Pro Tem Lilburn being absent.

Councilwoman Scott left the dais at 6:54 p.m.
