## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Pursuant to Title 14 of the California Code of Regulations, Sections 15072 and 15073, this is to advise that the City of Highland, which is the lead agency overseeing this project, has completed a Mitigated Negative Declaration for the proposed project described below.

PROJECT TITLE & FILE No.: Tentative Tract Map-018-001 (TTM 20142 - Kiel 54) ENV-018-014

PROJECT LOCATION: 29996 Santa Ana Canyon Road. (APNs: 1210-371-06, 10, & 11).

**PROJECT DESCRIPTION:** Application proposes to subdivide approximately 21.6 acres into 54 lots with a minimum lot size of 10,000 sq. ft. Development of the tract will include: grove removal, grading, development of internal roadways, improvements to Santa Anna Canyon Road, and a water retention basin.
